NOTICE OF UNITED STATES POSTAL SERVICE OF FILING SECOND ERRATA

The United States Postal Service hereby provides notice of the filing of errata to the proposed Rate and Fee Schedules, marked as Attachment A to the Request, and the proposed changes in the Domestic Mail Classification Schedule (DMCS), marked as Attachment B to the Request. Certain minor revisions to Rate Schedules 323B and 324 are reflected in the four revised pages of Attachment A, filed herewith. The changes contained in those four pages, because they are minor and numerous, could more easily be reflected by filing the attached pages rather than including the changes in the list below. The additional revisions to Attachment A and Attachment B are as follows:
