ERRATA TO PUBLIC REPRESENTATIVES' COMMENTS AND SIGNATURE PAGE

The Public Representatives hereby serve notice of the following errata to its initial comments, accepted for filing on February 2, 2009, in this docket.

Page 4, paragraph 1, line 1:

Change "Graph 1" to read "Graph 2".

Delete the sentence beginning on line 3, "It corroborates..." and accompanying footnote.

Page 5, paragraph 1, line 1:

Change "Graph 2" to read "Graph 1".

Page 7, second full paragraph, line 4:

Change "deficit trend down" to read "net revenue trend up"; change "Figure 1" to read "Graph 1".

Page 8, second full paragraph, lines 4 and 5:

Change “upward trend in the deficit” to read “downward trend in net revenues”;
change “Figure 1” to read “Graph 1”.

Pages 9 and 14, Tables 1 and 2:

Change all “?” symbols to “Δ” symbols.

Page 12, second full paragraph, line 10:

Delete the semi-colon.

Page 15, paragraph 1, line 4:

After the word “turn,” add the word “is”.

Page 19, first full paragraph, line 8:

Delete the word “for”.

Page 20, paragraph 1, lines 1 and 2:

Add the word “in” at the end of line 1;

Delete the word “for” before the word “Periodicals” in line 2.

Page 22, paragraph 1, lines 7 and 8:

Delete the sentence "However, the large percent increase shown for the latter is actually due to the addition of a very large number of NSAs during FY 2008."

Page 22, paragraph 1, line 7:

After the word "Mail." Insert the following footnote: "The large volume growth for International Mail from FY 2007 to FY 2008 is due to inclusion of inbound mail. Prior to this year, only outbound mail was recorded in the CRA."

Page 25, line 1:

After the word "be", add the word "in".

Page 26, after Table 9, add:
