**JOINT MOTION OF THE UNITED STATES POSTAL SERVICE
AND CAPITAL ONE SERVICES, INC.
TO POSTPONE PREHEARING CONFERENCE**

(February 11, 2009)

The United States Postal Service and Capital One Services, Inc. (Capital One) hereby move to postpone the prehearing conference in this docket by two weeks. As background, the Presiding Officer scheduled a prehearing conference in this docket for February 12, 2009, to “better inform the Commission of the progress on discovery and to understand the expectations of both parties on bringing this case to a timely conclusion.” P.O. Ruling No. C2008-3/34 at 2 (January 28, 2009).

Over the past few months, the parties have engaged in extensive negotiations regarding discovery issues. These discussions have been mutually beneficial, as several issues have been resolved informally, without contentious motions practice before the Commission. In light of recent discussions, both parties believe that a conference tomorrow would be premature, and they respectfully request a two week postponement of the prehearing conference now scheduled for February 12, 2009.

WHEREFORE, the movants request that the Presiding Officer issue a ruling delaying the prehearing conference in this docket for two weeks.
