**NOTICE OF ERRATA TO UNITED STATES POSTAL SERVICE NOTICE OF  
CHANGES IN RATES OF GENERAL APPLICABILITY FOR COMPETITIVE  
PRODUCTS ESTABLISHED IN GOVERNORS' DECISION NO. 09-01**  
(April 9, 2009)

On February 10, 2009, the United States Postal Service gave notice of changes in rates of general applicability and of concomitant classification changes for competitive products (Competitive Notice).<sup>1</sup> In accordance with 39 C.F.R. § 3015.2(b), the Competitive Notice provided the Governors' Decision establishing the changes, which orders the changes into effect on May 11, 2009. Subsequent review identified an omission in the price charts in the Mail Classification Schedule (MCS) language included as Attachment B to the Governors' Decision. The omission relates to the charge for Pickup on Demand service, by which customers can schedule same-day or recurring, special pickups of Parcel Post Single-Piece, Express Mail, Priority Mail, Outbound International Expedited Services, and Outbound Priority Mail International items. The change in price from \$14.75 to \$15.30 per pickup stop was indicated with respect to Parcel Post Single-Piece in the MCS language accompanying the Notice of Market-Dominant Price Adjustment (Market-Dominant Notice) that the Postal Service

filed the same day as the Competitive Notice,<sup>2</sup> yet the change was inadvertently omitted in the materials filed in the Competitive Notice.

The relevant classification text is attached to this Notice, and the Postal Service has sent a corresponding notice of correction for publication in the *Federal Register*. Postal Service management has advised the Governors of this matter and has provided them with information concerning the corrected fees. Customers should already be aware of the increase in the Pickup on Demand charge for domestic products, because the new price already appeared in the price charts that were published with the Domestic Mail Manual changes in the *Federal Register*.<sup>3</sup>
