**NOTICE OF UNITED STATES POSTAL SERVICE OF
CLASSIFICATION CHANGE**

August 18, 2009

Pursuant to 39 C.F.R. §§ 3020.90 and 3020.91, the United States Postal Service (Postal Service) hereby gives notice of a change in classification governing Global Express Guaranteed (GXG) service. The change modifies the requirements regarding eligibility for online discounts for GXG service. This minor change is designed to reflect current practice. Previously, customers were eligible for online discounts for the Postal Service's GXG service through registration via the GXG web site at usps.com. Now, customers purchase online discounted postage for GXG service and other international expedited and parcel services through Click-N-Ship at usps.com or through other commercial online postage providers.

The Postal Service hereby submits to the Commission the attached conforming change in the Mail Classification Schedule. The change in the MCS will give effect to changes in the International Mail Manual to be made effective on September 8, 2009. The Postal Service believes that the change is consistent with 39 U.S.C. § 3642 and should be incorporated by the Commission into the MCS.
