**UNITED STATES POSTAL SERVICE QUARTERLY UPDATE IN RESPONSE  
TO ORDER NO. 162**  
(October 1, 2009)

In Order No. 162, the Postal Regulatory Commission (PRC) added Inbound International Expedited Services 2 to the Competitive Product List.<sup>1</sup> This order also directed the Postal Service to file a quarterly update of the “list organizing the [inbound express mail international] agreements to be grouped under each of the three tiers” of service.<sup>2</sup> The three service tiers include the following:<sup>3</sup>

- 1) Pay-for-performance: Members of the Kahala Post Group and EMS Cooperative members who elect to comply with pay-for-performance provisions;
- 2) EMS Cooperative: EMS Cooperative members who elect not to comply with pay-for performance provisions; and
- 3) All Others: Foreign postal administrations who choose not to be members of the EMS Cooperative.

The Attachment identifies the countries assigned to each tier from July 1, 2009, through October 1, 2009.
