**PETITION TO INTERVENE BY THE CITY OF STEAMBOAT SPRINGS, CO**

1. This petition to intervene is filed by the City of Steamboat Springs, CO (“City”). The City of Steamboat Springs is interested in the proposed closure by the United States Postal Service of the Sundance Plaza postal facility and relocation of postal box services provided at the Sundance Plaza facility to the Steamboat Springs Post Office.
2. The City claims an interest in the impact of the proposed closure due to its impact on the community. 39 U.S.C. Section 404(d)(2)(a)(i) establishes that the City’s interest warrants intervention. The City’s interest is more particularly described the letter attachment to the Brief filed contemporaneously with this Petition.
3. The City does not request a hearing. The City will actively participate in any hearing to the extent feasible, though it is unlikely the City’s

participation would extend to sending representatives to a hearing located out of state.

4. Per the Commission's January 21, 2010 Notice and Order, the deadline for petitions to intervene is February 16, 2010. Therefore, this petition is timely.

**WHEREFORE**, the City of Steamboat Springs, CO hereby requests that its petition to intervene be allowed and that the brief filed contemporaneously with this petition be accepted for the Commission's review and consideration.
