3. Please provide billing determinants for each market dominant product for FY 2008, with volumes separated between those sent before the implementation of the Docket No. R2008-1 rate increase (May 12, 2008) and those sent after the increase. Refer to the FY 2009 billing determinants for First-Class Mail (USPSFY09-4, 09 FCM.xls) for an example of the format for this presentation.

RESPONSE:

Please see ChIR.4.Q.3.FY08.BDs.zip, attached to this response electronically, which contains FY 2008 Q3 billing determinants for First-Class Mail, Periodicals, Standard Mail, Single-Piece Parcel Post, Bound Printed Matter Flats, Bound Printed Matter Parcels, and Media Mail/Library Mail, split into before-rates and after-rates periods. The Postal Service previously supplied quarterly billing determinants for FY 2008 Q1, Q2 and Q4 in USPS-FY08-4 as part of the 2008 ACR. The split Q3 data, together with the previously supplied quarterly data, provide the FY 2008 billing determinants data with volumes separated by rate period, comparable to that shown in USPS-FY09-4, 09 FCM.xls for First-Class Mail, using the standard format for each product's billing determinants.
