**NOTICE OF REILING AS PUBLIC DOCUMENTS
OF EXHIBIT F AND EXHIBIT H TO THE INITIAL COMMENTS
OF THE PUBLIC REPRESENTATIVES**

(May 25, 2010)

Pursuant to the Commission's Order No. 458¹, the Public Representatives hereby submit for filing as public documents Exhibit F (Revised) and Exhibit H (Revised) to their initial comments in this proceeding.²

Background

On March 2, 2010, the Public Representatives filed a non-public annex to accompany their initial comments.³ The non-public annex contained Exhibit F and Exhibit H to those comments. These exhibits were filed in a non-public annex as a temporary means of accommodating claims by the Postal Service that the information contained in Exhibit F and supplied to the Public Representatives voluntarily on a confidential basis should not be made public.⁴ The Public Representatives reserved the right to seek public disclosure of the exhibits at a future date.

In response to a motion by the Public Representatives to make Exhibit F and Exhibit H public, the Postal Service agreed that both exhibits could be made public,

except for those portions of Exhibit F that set forth the number of customers (customer counts) for each of the post offices whose operations had been suspended.⁵ The Public Representatives agreed to the continued confidential treatment of the customer counts and withdrew their motion for a show cause order.⁶

In Order No. 458, the Commission authorized the Public Representatives to re-file Exhibit F and Exhibit H as public documents, provided the Public Representatives first confirmed with the Postal Service that the revised exhibits do not contain any non-public customer count information. Order No. 458 at 2.

The Documents Being Filed

The Public Representatives have revised their Exhibit F to remove both the customer count information and the “Confidential” watermark that appears on the non-public version of Exhibit F. The revised exhibit is named “Exhibit F (Revised).”⁷ The Postal Service has confirmed that Exhibit F (Revised) does not contain any non-public customer count information.

Exhibit H, which requires no redactions for non-public customer count information, has been revised to remove the “Confidential” watermark. While this revision is relatively minor, the Public Representatives have redesignated this exhibit as “Exhibit H (Revised)” in order to avoid any unnecessary future confusion over the two versions of the document.

Both Exhibit F (Revised) and Exhibit H (Revised) are attached hereto.

Exhibit H (Revised)

The Public Representatives have performed the following analysis on the database of Post Offices suspended for lease termination provided by the Postal Service on 1/20/2010 and referred to in the Initial Comments of the Public Representatives as Exhibit F (Non-Public). This analysis of the non-public document is similar to the analysis of the public database in Exhibit G.

The Postal Service database is broken into three parts: offices suspended, closed and restored. A justification is provided for each office, such as disaster. In almost all cases, the Postal Service also states that no alternative quarters were appropriate, but that justification does not appear as the sole reason for suspending an office.

The timelines are close to those contained in Exhibit G. There are no offices suspended before 2004 in this database, so the overall timelines are shorter because they are more recent. The same pattern of reopening offices quickly, and letting the vast majority of suspended offices languish in suspension. The average time that it takes to reopen a Post Office, 0.71 years (8.57 months), closely matches the amount of time the Postal Service states it takes to perform the full discontinuance study.
