Pursuant to 39 U.S.C. § 407(d)(2), the U.S. Postal Service (Postal Service) is providing copies of signature pages from countries that have signed a standard revised EMS Operational Agreement concerning the exchange of EMS items between postal operators. The EMS Operational Agreement at issue was submitted to the Postal Regulatory Commission on May 14, 2010, along with initial signature pages from 23 foreign postal operators. The instant submission consists of an additional 8 signature pages from foreign postal operators that have signed the standard template agreement. The Postal Service will file additional signature pages for agreements executed with other postal operators that are agencies of foreign governments after they are received, as well as copies of any agreements (or portions thereof) that differ from the standard template.




