Attached are two examples of a Payment Notice for PO Box Service that have been distributed to box holders here in Crescent Lake. I have received telephone calls commenting on these forms. Once again here is another example of the "empty words" that the United States Postal Service (USPS) officials make to the residents, visitors, and guests of Crescent Lake, Oregon.

We are told time after time that we are "Crescent Lake" that we do not need to use "Crescent" as our mailing address. But then when we receive a notice with blatant disregard to our community's history and identity. We are tired of the USPS attempting to remove our town's individuality. Is there no integrity? Empty words that sounds nice to upper management leaves a town and community fed up and angry. If we were to question the forms, which we have in the past, we are told that it is the computer system and the forms are generated out of the Crescent, Oregon Post Office. Well, this is a perfect example of what we have been saying. If your own computers can not distinguish between Crescent and Crescent Lake then this explains all the lost and mis-delivered mail.

Please consider the recommendations of the Public Representative, Cassandra Hicks filed May 25, 2010; Docket A2010-4. We need a zip code of our own. We need some sort of mail processing here in Crescent Lake, Oregon at our own post office facilities. The attached documents are examples of why our mail is misdirected, mishandled, and just plain LOST. We are Crescent Lake not Crescent. Crescent is a town, whose distance from post office to post office, is over 17 road miles away.
