**AMERICAN POSTAL WORKERS UNION, AFL-CIO, MOTION FOR ACCESS BY  
JENNIFER L. WOOD TO NON-PUBLIC INFORMATION  
IDENTIFIED AS USPS-LR-N2010-1/NP6  
(July 21, 2010)**

Pursuant to 39 CFR 3007.40 and Rule 21 of the Commission's Rules of Practice and Procedure, the American Postal Workers Union, AFL-CIO (APWU) hereby moves for access by one of its attorneys, Jennifer L. Wood, to certain Postal Service materials filed in the Non-Public Annex of this docket.

On July 13, 2010, the APWU filed a Motion for Access to non-public Library Reference, USPS-LR-N2010-1/NP6 Unredacted Electronic Diversion Materials Provided Under Seal in Response to NALC/USPS-T2-32 and 33 (Non-Public Version) by Darryl J. Anderson, Phillip Tabbita and Kathryn Kobe.<sup>1</sup> That Motion is hereby incorporated by reference. At the time of filing this Motion, Ms. Wood was out of the country and therefore, unable to provide the Postal Regulatory Commission with an original signed Statement of Compliance with Protective Conditions Certification. However, in accordance with 39 CFR 3007.40(b), Ms. Wood has now completed a Statement of Compliance with Protective Conditions Certification, found in Appendix A to Part 3007 of Title 39 of the Code of Federal Regulations, for Library Reference USPS-LR-N2010-1/NP6. A copy of this Certification is attached hereto. The original Certification has been filed with the Commission today. Persons identified by the Postal Service pursuant to Section 3007.2(c) have also been provided with a copy of this Motion and accompanying certification today by email. As of today, no objection has

For the forgoing reasons, APWU respectfully requests that access to Library Reference USPS-LR-N2010-1/NP6 be granted to Ms. Wood.


