LETTER POST BILATERAL AGREEMENT**

(August 27, 2010)

On August 13, 2010, the Postal Service filed the initial Request and Notice in this proceeding. That filing included as Attachment 3B the bilateral agreement with China Post Group that is the subject of Docket No. R2010-6. Subsequent review revealed that the filed agreement inadvertently contained a pre-final version of Annex 3, which was presented in full in both the public and nonpublic versions. The parties have executed a modification to clarify the version of Annex 3 that should be incorporated within the final agreement. In the interest of transparency and a complete record in this proceeding, the Postal Service hereby files the corrected Annex 3, which may be substituted in both the public and nonpublic versions of Attachment 3B to its initial Request and Notice.





