**ERRATUM TO UNITED STATES POSTAL SERVICE NOTICE OF  
FILING OF ADMINISTRATIVE RECORD**  
(February 10, 2011)

The United States Postal Service (Postal Service) hereby provides notice of filing an additional one-page document that was omitted from the electronic version of the administrative record concerning the Final Determination to Close the Holmes Mill, KY Post Office and Extend Rural Route Service (Final Determination) filed on December 22, 2010, in the docket referenced above. The attached document should be added between PDF pages 168 and 169 of the Postal Service's December 22, 2010, notice of filing of the administrative record in this docket. The omission of the document was brought to counsel's attention by the Public Representative.

The Postal Service recently learned that the document includes a typographical error. The document date in this internal memorandum should be in calendar year 2010, not the December 17, 2009 date as the document indicates. Counsel is informed that the letter was created and signed sometime between October 12, 2010, when the Final Determination transmittal letter from Postal Service Headquarters was signed, and November 8, 2010, when the Final Determination was posted in the affected post offices.<sup>1</sup>


Please post in the lobby the enclosed final determination to close the Holmes Mill Post Office. The final determination must be posted in a prominent place from November 8, 2010 through close of business on December 10, 2010. It must be posted for at least 30 days and the first day does not count. Additionally, please take down the posted "Notice of Taking Proposal and Comments under Internal Consideration" and return to this office.

Round-date stamp the cover of the final determination on the date of posting and on the date of removal. Please send the final determination to Post Office Review Coordinator Tim Reynolds by close of business on December 10, 2010.

Additional copies of the final determination are enclosed. Provide them to customers upon request. Also round date one final determination and retain behind counter. It is imperative that the Final Determination is correctly posted in your lobby and round dated on the correct dates.

Also enclosed is the official record upon which this final determination is based. Customers may read it; however, they may not remove it from your office. When a customer requests a copy of the record, provide it upon payment of any fees prescribed in *Administrative Support Manual*, Section 352.6. If you do not have photocopy equipment, take the customer's name, address and telephone number and contact the district for needed copies.
