Petition summary and background	<i>This Petition has been generated to voice the Tateville communities concerns & the citizen's rejection of the proposed closing of the Tateville, KY Post Office by the U.S. Postal Service.</i>
Action petitioned for RECEIVED 2011 MAY 12 P 10:36 POSTAL REGULATORY COMMISSION OFFICE OF THE SECRETARY	<p>We, the undersigned, are concerned citizens who urge our State & Counties leaders to act now to reject the Federal closing of the Tateville, KY Post office. We do not want our local Postal Services transferred to the Burnside, KY Post Office creating unnecessary hardships on our citizens to receive & maintain general Postal Services in our own community. The US Postal Service is not assuming any financial costs of our communities businesses, or citizens for the correspondence in which must be sent out to change business and general mailing addresses with our customers and other entities. Further they are not assuming any cost or liability of fuel and maintenance on our personal vehicles to travel to and from Burnside, KY to receive general Postal services. The \$14.00 savings from Tateville to Burnside Post Office does not substantiate the expense in which the Tateville citizen will have to absorb in an already struggling economy and tight household budgets. The USPS stated that it will be the citizens responsibility to research laws that govern placement of Mail boxes on our own and others property to meet carrier needs; if a neighbor disputes the placement of your box on their property to meet carrier needs it will be of your responsibility to address the issue for resolve they assume no liability. The USPS also stated they will not provide federal investigations if our mail is stolen from our boxes & that it will be up to the local law enforcement agencies to address these types civil or criminal mischief which then affects the citizens of Tateville's tax money and place responsibility on an already over exerted Sheriffs Department. Senior Citizens or those that are handicapped may request through the USPS that a mailbox be placed on their home, however regular citizens do not qualify for this type of service although larger cities within in Kentucky have door to door carrier service for their areas. USPS stated that the costs associated with paying their carriers to deliver to the home having to exit their vehicle costs them additional monetary expenses; considering most carriers are contracted. The question now has to distinguish a form of discrimination since what is good for one American citizen should be equal to all on something as simple as mailbox placement and Postal Services! The US Postal Service has not identified to the citizens of Tateville any legitimate reason to the citizens of Tateville, KY any other reason to close the Tateville Post Office then to save them money at the cost both monetarily and physically to the citizens of Tateville. We condemn the USPS request to close our Local Post Office.</p>
