**NOTICE OF THE UNITED STATES POSTAL SERVICE OF FILING MODIFICATION  
TO GLOBAL EXPEDITED PACKAGE SERVICES – NON-PUBLISHED RATES 2  
CUSTOMER CONTRACT SERIAL NUMBER ENDING: 0065  
(May 20, 2011)**

On April 8, 2011, the United States Postal Service (Postal Service) gave notice of filing, in the above-referenced docket, Global Expedited Package Services – Non-Published Rates 2 (GEPS NPR 2) customer agreements with serial numbers ending in 0065 and 0068-0079.<sup>1</sup> This notice concerns the customer agreement with the serial number NPR2-FY11-FEB11-M-T2-0065 (Agreement), an unredacted version of which was filed with the Commission under seal, as part of the Postal Service's April 8, 2011 filing in this docket.

A modification of the customer agreement with the serial number NPR2-FY11-FEB11-M-T2-0065 (Agreement) was recently signed. The modification changes the address for the Mailer that is included in the first paragraph and Article 30 of the Agreement. A redacted version of the modification is filed publicly as Attachment 1, and an unredacted version of the modification is filed under seal. With respect to the non-public version of the modification which is filed under seal, the Postal Service hereby

**MODIFICATION ONE TO THE  
GLOBAL CUSTOMIZED MAIL AGREEMENT BETWEEN  
THE UNITED STATES POSTAL SERVICE AND**

This Modification amends the Global Customized Mail Agreement ("Agreement") between [REDACTED] ("Mailer") with offices at [REDACTED] and the United States Postal Service ("USPS"), an independent establishment of the Executive Branch of the United States Government, with offices at 475 L'Enfant Plaza SW, Washington, DC 20260-9998, signed by the Mailer on March 8, 2011, and signed by the USPS on March 14, 2011. The Mailer and the USPS may be referred to individually as a "Party" and together as the "Parties."

This Modification shall make two changes to the Agreement.

**First change**

The first paragraph of the Agreement is changed to read as follows:

This Agreement ("Agreement") is between [REDACTED] ("Mailer"), with offices at [REDACTED] and the United States Postal Service ("USPS"), an independent establishment of the Executive Branch of the United States Government, with offices at 475 L'Enfant Plaza SW, Washington, DC 20260-9998. The Mailer and the USPS may be referred to individually as a "Party" and together as the "Parties."

**Second change**

Article 30. Notices is changed to read as follows:


All other terms and conditions of the Agreement shall remain in force.

The Mailer acknowledges that the Modification and supporting documentation will be filed with the Postal Regulatory Commission ("Commission") in a docketed proceeding (CP2011-45, Serial Number NPR2-FY11-FEB11-M-T2-0065). The Mailer authorizes the USPS to determine the scope of information that must be made publicly available in any Commission docketed proceeding. The Mailer further understands that any unredacted portion of the Modification or supporting information will be available on the Commission's public website, <http://www.prc.gov>. The Mailer has the right, in accordance with the Commission's rules, to address its confidentiality concerns directly with the Commission. The procedure for making an application to the Postal Regulatory Commission for non-public treatment of materials believed to be protected from disclosure is found at Title 39, Code of Federal Regulations, Section 3007.22 found on the Commission's website, <http://www.prc.gov/Docs/63/63467/Order225.pdf>.

The Parties may execute this Modification in one or more counterparts (including by facsimile or by electronic means such as .pdf format). Not all Parties need be signatories to the same document. All counterpart signed documents shall be deemed an original and one instrument.
