We want to appeal and request a petition for review of the Final Determination to close the Sublime Post Office.

Their Reasons given to close:

(1) Currently vacant –

**Our objection:** No posting by USPS to hire a new Post Master since January 2010. Not the community's fault; Office operating under an OIC and providing good service.

(2) Earns less than 1.55 hours daily –

**Our objection:** Title 39—Postal Service / Part I—General  
Chapter 1—Postal Policy and Definitions / Sec. 101. Postal policy

(b) The Postal Service shall provide a maximum degree of effective and regular postal services to rural areas, communities, and small towns where post offices are not self-sustaining. No small post office shall be closed solely for operating at a deficit, it being the specific intent of the Congress that effective postal services be insured to residents of both urban and rural communities.

(3) Office has no running water or restroom—

**Our objection:** US Code 404.(d) (2B) states:

The Postal Service may not consider compliance any portion of the Occupational Safety and Health Act of 1970 (29 USC 651).

(The Lutheran Church allows postal service employee to use their restroom facilities.)

The Postal Service is issuing the final determination to close the Sublime, TX Post Office and provide delivery and retail services by rural route service under the administrative responsibility of the Hallettsville Post Office, located 10 miles away. Service will be provided to cluster box units (CBUs).

CBUs are secure free-standing units of individually locked mail compartments installed and maintained by the Postal Service at no cost to the customer. A parcel locker may also be installed.

The postmaster position became vacant when the postmaster was promoted on January 12, 2010. Since the postmaster vacancy an OIC has been installed to operate the office. Postmaster level and office service hours are determined by a workload analysis which includes the number of deliveries and revenue.

The office was studied for possible closing or consolidation due to the following reasons: This office is currently vacant and earns less than 1.55 hours daily thus performing below standards to operate as an independent Post Office. This office has no running water or restroom facilities available for employees. Effective and regular service will continue via rural route service with retail services provided by the carrier alleviating the need to travel to a Post office for service

The Sublime Post Office, an EAS-53 level, provides service from 09:15 to 12:45 Monday - Friday , 09:15 to 12:45 on Saturday and lobby hours of 24 hours on Monday - Friday and 24 hours on Saturday to 48 post office box or general delivery customers and no delivery customers. Retail services included the sale of stamps, stamped paper, and money orders; special services such as Registered Mail, Certified Mail, Insured Mail, COD Mail, and Express Mail services; and the acceptance and dispatch of all classes of mail.

The retail window averaged nine transaction(s) accounting for 10 minute(s) of retail workload daily. With minimal workload, the Postal Service feels that effective and regular service will be provided by rural route service. Office receipts for the last 3 years were: \$19,611 ( 51 revenue units) in FY 2008; \$15,137 ( 39 revenue units) in FY 2009; and \$9,196 ( 24 revenue units) in FY 2010. There were no permit mailer(s) or postage meter customer(s).

On March 16, 2011, representatives from the Postal Service were available at to answer questions and provide information to customers. 13 customer(s) attended the meeting.

On March 02, 2011, 48 questionnaires were distributed to delivery customers of the Sublime Post Office. Questionnaires were also available over the counter for retail customers at the Sublime Post Office. 19 questionnaires were returned. Responses regarding the proposed alternate service were as follows: 0 favorable, 9 unfavorable, and 10 expressed no opinion.

When this final determination is implemented, delivery and retail services will be provided by the Hallettsville Post Office, an EAS-18 level office. Window service hours at the Hallettsville Post Office are from 08:00 to 16:00 , Monday through Friday, and 09:00 11:00 on Saturday. There are 54 post office boxes available.

\* The proposal to close the Sublime Post Office was posted with an invitation for comment at the Sublime Post Office and Hallettsville Post Office from April 18, 2011 to June 19, 2011. The following additional concerns were received during the proposal posting period:

\* 1. Concern:

Customer felt closing the Sublime Post office would result in a less efficient and friendly postal experience having been very satisfied with the convenience of the current operation.

Response:

We appreciate your concerns about the current operation of the Sublime Post office. The USPS will continue to strive to ensure that if the Sublime Post Office is discontinued, your experience with the local service will be duplicated.

2. Concern:

Customers expressed concern about having to erect a rural mailbox

Response:

The customer expressed concern about having to erect a rural mailbox. Customers are not required to erect rural mailboxes. Customers may receive PO Box service from the administrative Post Office located 9.6 miles away.

3. Concern:

Customers questioned the economic savings of the proposed discontinuance

Response:

The customer questioned the economic savings of the proposed discontinuance. Carrier service is more cost-effective than maintaining a postal facility and postmaster position. The Postal Service estimates an positive annual savings.

Customers were concerned about mail security when mail is left in box on Highway.

(b) "The Postal Service shall provide a maximum degree of effective and regular postal services to rural areas, communities, and small towns where post offices are not self-sustaining. Now small post office shall be closed solely for operating at a deficit, it being the specific intent of the Congress that effective postal services be insured to residents of both urban and rural communities." This quote from the U.S. Code deems this move illegal.

THEREFORE LET IT BE RESOLVED that the undersigned residents of the small rural communities and small towns of Texas shall call on all branches of the government of the United States to STOP the closing/consolidation of rural and small Post Offices,

LET IT BE FURTHER RESOLVED that a copy of this resolution be sent to the President and appropriate Managers of USPS, and the United States Congress; that the undersigned reflects the will of the people, who are the patrons of the United States Postal Service.
