Dear Chairman Goldway:

The Postal Service has posted the Final Determination to close the North Canton, CT post office and continue to provide service by an independent post office.

The attached list contains 114 signatures of customers served by the North Canton, CT post office that strongly oppose the decision to combine our post office with Canton Center. The postmaster plays an important role in our community, especially for the elderly and infirm. Many of our residents do not drive and they will be hard hit by this decision. Our small community relies on the post office for more than just stamps. It is the center of our town where we have the occasion to see neighbors and communicate with one and other.

Our little post office represents the federal government to our residents and it is hard for us to understand the reasoning. We understand that the Postal Service has financial issues but isn't it against the law to close a post office just to save money? How can the federal government spend billions of dollars in an attempt to create jobs and then a branch of the federal government eliminates vital jobs in small towns? Rural America is just as important as urban America. Post offices in urban America may be a luxury but in rural America they are a necessity.

It is important for us to save our History. There has been a post office in North Canton since 1826 and a piece of our heritage will be lost if you uphold the decision to close us down. Please reconsider the final determination and let our post office remain open.
