The citizens of the City of Basalt listed below, hereby formally appeal the proposed closure of the Basalt Post Office.

POSTAL REGULATORY COMMISSION

The Basalt Post Office was originally placed in service in 1888. It is a fixture of the community and is considered to be of historical significance to the residents of the area.

The appeal is issued because the community has come to depend on the security of the mail, the convenience to send parcels, etc. (especially for senior citizens), and the social atmosphere that this office offers.

We do not believe that the proposed cost savings warrant its closure. The office has not been managed by a formal postmaster for some time. The temporary employees have demonstrated that the office can be operated very efficiently at minimal operating cost.
