**REDACTED AMENDMENT TO PRIORITY MAIL CONTRACT 46**

**AMENDMENT OF  
SHIPPING SERVICES CONTRACT  
BETWEEN  
THE UNITED STATES POSTAL SERVICE  
AND  
[REDACTED]  
REGARDING PRIORITY MAIL SERVICE**

WHEREAS, the United States Postal Service (“the Postal Service”) and [REDACTED] (“Customer”) entered into a shipping services contract regarding Priority Mail service on September 21, 2012.

WHEREAS, the Parties desire to amend the Annual Adjustment provision of this contract.

NOW, THEREFORE, the Parties agree that the contract is hereby amended as detailed below. The existing contract remains unchanged in all other respects. This amendment shall become effective one business day after the Commission issues all necessary regulatory approval.

Paragraph I.G. is amended to state the following:

1. For the second year of the contract, beginning on the first anniversary of the contract’s effective date, prices for Contract Packages will be the first year’s prices plus the most recent (as of the anniversary date) average increase in prices of general applicability, as calculated by the Postal Service, for Priority Mail Commercial Plus.
2. For the third year of the contract, beginning on the second anniversary of the contract’s effective date, prices for Contract Packages will be the second year’s prices plus the most recent (as of the anniversary date) average increase in prices of general applicability, as calculated by the Postal Service, for Priority Mail Commercial Plus.
