**CUSTOMER CONTRACT FILING NOTICE FOR  
GLOBAL EXPEDITED PACKAGE SERVICES – NON-PUBLISHED RATES 4  
SERIAL NUMBERS ENDING: 0059, 0061-0062 AND 0065-0067  
(July 2, 2013)**

In compliance with Order No. 1625,<sup>1</sup> the United States Postal Service gives notice of filing Global Expedited Package Services – Non-Published Rates 4 (GEPS NPR 4) customer agreements with serial numbers ending in 0059, 0061-0062 and 0065-0067.<sup>2</sup> The effective dates for the six agreements filed with this notice are listed below.

The Postal Service is filing these six contracts with the Commission under seal. The six agreements are derived from a common template<sup>3</sup> and would appear essentially the same when redacted. Therefore, the Postal Service requests that the Commission consider the redacted version of the customer agreement with serial number NPR4-

FY13-JAN13-N-T5-0001, filed in this docket as Attachment 1 to the Postal Service's notice dated February 6, 2013, as representative of the contracts filed.<sup>4</sup>

The unredacted versions of the inputs worksheets that were used to generate customer-specific rate tables for the six agreements for which the Postal Service is providing notice are being filed with the Commission under seal. The redacted version of these input worksheets would appear very similar to the redacted inputs worksheet for the NPR4-FY13-JAN13-N-T5-0001 agreement that was included in the Postal Service's February 6, 2013 filing in this docket.<sup>5</sup> Therefore, the Postal Service requests that the Commission consider the redacted inputs worksheet for the NPR4-FY13-JAN13-N-T5-0001 agreement as representative of the inputs worksheets that the Postal Service is filing today under seal with the Commission.

The Postal Service incorporates by reference the application for non-public treatment that was filed in conjunction with the Postal Service's December 21, 2012, notice in this docket.<sup>6</sup> The application protects from disclosure information in the contracts and inputs worksheets that the Postal Service is filing today with the Commission under seal in this docket.
