**NOTICE OF UNITED STATES POSTAL SERVICE OF
CHANGE IN TERMS PURSUANT TO
AMENDMENT TO PARCEL SELECT CONTRACT 7**
(October 18, 2013)

The Postal Service hereby provides notice of filing an amendment to Parcel Select Contract 7, in the above-captioned proceeding, pursuant to Commission Order No. 1832 (September 11, 2013). The amendment corrects the date contained in Section I.E.3 of the contract. As the Postal Service reported in its status report filed on September 30, 2013, the Postal Service was prepared to file the instant amendment later that week. However, the Postal Service was unable to file materials under seal during the government shutdown, including this amendment.

A redacted version of the amendment to Parcel Select Contract 7 is provided in Attachment A, and the unredacted amendment is being filed under seal. The amendment will become effective one day after the day that the Commission completes its review of this filing. The financial workpapers initially provided by the Postal Service in this docket remain applicable. The Postal Service's original application for non-public treatment in this docket is hereby incorporated by reference for the protection of these materials.

REGARDING PARCEL SELECT SERVICE

WHEREAS, the United States Postal Service (“the Postal Service”) and [REDACTED] (“Customer”) entered into a shipping services contract regarding Parcel Select Service on 08/27/2013.

WHEREAS, the Parties desire to amend the terms in Section I.E.3, Customer’s Price Calculation.

NOW, THEREFORE, the Parties agree that the contract is hereby amended as detailed below. The existing contract remains unchanged in all other respects. This amendment shall become effective on the day after the day the Commission issues all necessary regulatory approval.
