**NOTICE OF THE UNITED STATES POSTAL SERVICE OF FILING MODIFICATIONS
TO GLOBAL EXPEDITED PACKAGE SERVICES – NON-PUBLISHED RATES 4
CUSTOMER CONTRACTS WITH SERIAL NUMBERS ENDING IN
-0003 TO -0012, -0014 TO -0015, -0017 TO -0022, -0024 TO -0054, -0056 TO -0058,
-0060 TO -0076, -0078 TO -0087, -0089 TO -0091, -0093 TO -0095, AND -0097
(January 14, 2014)**

On August 28, 2013, the United States Postal Service (Postal Service) gave notice to the Postal Regulatory Commission (Commission) of changes to the Global Expedited Package Services – Non-Published Rates (GEPS – NPR) 4 contract.¹ In Order No. 1835, the Commission directed that the Postal Service file modifications amending Article 15 in GEPS – NPR 4 agreements in this docket.²

The Postal Service is providing notice of filing modifications to 86 GEPS – NPR 4 contracts with the Commission under seal, which amend Article 15 in the GEPS – NPR 4 contracts with the serial numbers ending in -0003 to -0012, -0014 to -0015, -0017 to -0022, -0024 to -0054, -0056 to -0058, -0060 to -0076, -0078 to -0087, -0089 to -0091, -0093 to -0095, and -0097. The revised Article 15 in each of the modifications being filed is derived from Article 15 of the GEPS – NPR 4 revised model contract that the

Commission reviewed in Order No. 1835.³ The modifications would appear essentially the same when redacted. Therefore, the Postal Service is filing publicly, as Attachment 1, a representative redacted version of one of the modifications, the redacted version of the modification to the customer agreement with serial number NPR4-FY13-JAN13-N-T6-0003. In addition, the Postal Service is filing, as Attachment 2, a redacted version of the modification to the customer agreement with serial number NPR4-FY13-MAR13-M-T1-0042, because that modification includes revisions to not only Article 15 but also to the Preamble and Article 31 Notices of the agreement. The Postal Service incorporates by reference the application for non-public treatment that was filed in conjunction with the Postal Service's December 21, 2012, notice in this docket.⁴ The application protects from disclosure information in the modifications that the Postal Service is filing today with the Commission under seal in this docket.

This Modification amends the Global Customized Mail Agreement ("Agreement") between [REDACTED] ("Mailer"), with offices at [REDACTED] and the United States Postal Service ("USPS"), an independent establishment of the Executive Branch of the United States Government, with offices at 475 L'Enfant Plaza SW, Washington, DC 20260-9998, signed by the Mailer on January 22, 2013, and signed by the USPS on January 23, 2013. The Mailer and the USPS may be referred to individually as a "Party" and together as the "Parties."

The purpose of this Modification is to change the wording of Article 15. Postage Updates. Article 15. Postage Updates shall now read as follows:

ARTICLE 15. POSTAGE UPDATES

1. In the event that the USPS incurs an increase in costs [REDACTED] [REDACTED] associated with providing this service, the USPS shall notify the Mailer and modify the prices established under this Agreement. [REDACTED]
2. The USPS will give the Mailer thirty (30) days' notice of changes to the prices in Annex 1 and Annex 2.
3. Any revision of prices in Annex 1 and Annex 2 shall not be retroactive.
4. No price shall increase beyond the non-discounted published price for the affected service.

All other terms and conditions of the Agreement shall remain in force.





THE UNITED STATES POSTAL SERVICE AND**

This Modification amends the Global Customized Mail Agreement ("Agreement") between [REDACTED] ("Mailer") with offices at [REDACTED] and the United States Postal Service ("USPS"), an independent establishment of the Executive Branch of the United States Government, with offices at 475 L'Enfant Plaza SW, Washington, DC 20260-9998, signed by the Mailer on April 9, 2013, and signed by the USPS on April 11, 2013. The Mailer and the USPS may be referred to individually as a "Party" and together as the "Parties."

The purposes of this Modification are to change the wording of Article 15. Postage Updates, to change the Mailer's address in the Preamble and Article 31 Notices, and to change the words "Express Mail" to "Priority Mail Express" in Article 31 Notices.

The Preamble shall now read as follows:





