**NOTICE OF THE UNITED STATES POSTAL SERVICE OF TERMINATION OF  
GLOBAL EXPEDITED PACKAGE SERVICES -- NON-PUBLISHED RATES 4  
CUSTOMER CONTRACT WITH SERIAL NUMBER ENDING: 0060**

(February 19, 2014)

On June 10, 2013, the United States Postal Service (Postal Service) gave notice of filing, in the above-referenced docket, Global Expedited Package Services Non-Published Rates 4 customer agreements with serial numbers ending in 0041, 0052-0058 and 0060.<sup>1</sup> This notice concerns the customer agreement with the serial number NPR4-FY13-APR13-N-T4-0060, an unredacted version of which was filed with the Commission under seal, as part of the Postal Service's June 10, 2013 filing in this docket.

In accordance with Commission Order No. 1625,<sup>2</sup> the Postal Service hereby advises that the termination date is February 17, 2014, for the customer agreement with the serial number NPR4-FY13-APR13-N-T4-0060, as agreed to by the customer in a modification to the contract. A redacted version of the modification is filed publicly as Attachment 1. With respect to the non-public version of the modification that is filed

under seal, the Postal Service hereby incorporates its Application for Non-Public Treatment filed in conjunction with its December 21, 2012 notice in this docket.<sup>3</sup>

Therefore, the Postal Service now asks the Commission to remove the customer agreement with the serial number NPR4-FY13-APR13-N-T4-0060 from the competitive products list effective February 17, 2014.

**MODIFICATION TWO TO THE  
GLOBAL CUSTOMIZED MAIL AGREEMENT BETWEEN  
THE UNITED STATES POSTAL SERVICE AND**

[REDACTED]

This Modification amends the Global Customized Mail Agreement ("Agreement") between [REDACTED] ("Mailer") with offices at [REDACTED] and the United States Postal Service ("USPS"), an independent establishment of the Executive Branch of the United States Government, with offices at 475 L'Enfant Plaza SW, Washington, DC 20260-9998, signed by the Mailer on May 31, 2013, and signed by the USPS on May 31, 2013, as modified by Modification One signed by [REDACTED] on October 28, 2013, and by the USPS on November 4, 2013. The Mailer and the USPS may be referred to individually as a "Party" and together as the "Parties."

The purpose of this Modification is to change the wording of Article 12 Term of the Agreement.

Article 12 Term of the Agreement shall now read as follows:

**ARTICLE 12. TERM OF THE AGREEMENT**

The USPS will notify the Mailer of the Effective Date of the Agreement as soon as possible, but no later than thirty (30) days, after receiving the signed Agreement from the Mailer. The Agreement shall remain in effect until 11:59 p.m. on February 17, 2014, unless terminated sooner pursuant to Article 13 or Article 14.

All other terms and conditions of the Agreement shall remain in force.

The Mailer acknowledges that the Modification and supporting documentation will be filed with the Postal Regulatory Commission ("Commission") in a docketed proceeding (CP2013-35 Serial Number NPR4-FY13-APR13-N-T4-0060). The Mailer authorizes the USPS to determine the scope of information that must be made publicly available in any Commission docketed proceeding in which information related to this Modification must be filed. The Mailer further understands that any unredacted portion of the Modification or supporting information will be available on the Commission's public website, <http://www.prc.gov>. In addition, the USPS may be required to file information in connection with this instrument (including revenue, cost or volume data) in other Commission dockets, including Commission docket numbers ACR2014 and/or ACR2015. The Mailer has the right, in accordance with the Commission's rules, to address its confidentiality concerns directly with the Commission. The procedure for making an application to the Commission for non-public treatment of materials believed to be protected from disclosure is found at Title 39, Code of Federal Regulations, Section 3007.22 found on the Commission's website, <http://www.prc.gov/Docs/63/63467/Order225.pdf>.



