In compliance with Order No. 1959,² the United States Postal Service gives notice of filing Global Expedited Package Services – Non-Published Rates 4 (GEPS NPR 4) Version 2 customer agreements with serial numbers ending in 0061 to 0071.³ The effective dates for the eleven agreements filed with this notice are listed below.

The Postal Service is filing these eleven contracts with the Commission under seal. The agreements are derived from a common template⁴ and would appear essentially the same when redacted. Therefore, the Postal Service requests that the Commission consider the redacted version of the customer agreement with serial number NPR4.2-FY14-JAN14-I-T7-0001, filed in this docket as Attachment 1 to the

Postal Service's notice dated February 24, 2014,⁵ as representative of the contracts filed.

The unredacted versions of the inputs worksheets that were used to generate customer-specific rate tables are being filed with the Commission under seal. The inputs worksheets are very similar to the inputs worksheet that was included in the Postal Service's notice dated February 24, 2014.⁶ Therefore, the Postal Service requests that the Commission consider the redacted inputs worksheet for the NPR4.2-FY14-JAN14-I-T7-0001 agreement that was included in the Postal Service's February 24, 2014 notice as representative of the inputs worksheets that the Postal Service is filing today under seal with the Commission.

The Postal Service incorporates by reference the application for non-public treatment that was filed in conjunction with the Postal Service's December 26, 2013, notice in this docket.⁷ The application protects from disclosure information in the contracts and inputs worksheets that the Postal Service is filing today with the Commission under seal in this docket.
