

WHEREAS, the United States Postal Service (“the Postal Service”) and   
 (“Customer”) entered into a shipping services contract regarding Priority Mail service on March 27, 2014.

WHEREAS, the Parties desire to amend Terms I.E for Customer under this contract.

NOW, THEREFORE, the Parties agree that the contract is hereby amended as detailed below. The existing contract remains unchanged in all other respects. This amendment shall become effective one business day following the day on which the Commission issues all necessary regulatory approval.

I. Terms

E. Volume Commitment. Customer shall mail at least  Priority Mail packages during the first year of the contract, and shall mail at least  Priority Mail packages annually for subsequent years of the contract.
