ORDER CONCERNING AMENDMENT TO
PHI ACQUISITIONS, INC. NEGOTIATED SERVICE AGREEMENT

(Issued February 4, 2015)

On December 22, 2014, the Postal Service filed a notice of an amendment to the PHI Acquisitions, Inc. Negotiated Service Agreement (Agreement).¹ A copy of the amendment was filed with the Notice. The amendment adds a new section III.F to the Agreement, explaining how the Agreement's quarterly baseline volumes and annual

volume threshold will be adjusted in the event that the exigent surcharge approved in Docket No. R2013-11 is removed. The amendment does not make any additional changes to the Agreement and will be effective one business day after the day that the Commission issues all necessary regulatory approval.

In Order No. 2097, the Commission ordered the Postal Service to file an amendment containing a threshold adjustment mechanism for a price decrease, based on the steps it described in response to Chairman's Information Request No. 4, question 2.² The amendment filed in conjunction with the Notice satisfies the Commission's directive and makes no other changes to the Agreement. Consequently, the Commission reaffirms its findings in Order No. 2097 and approves the amendment.

It is ordered:

The amendment filed in Docket No. MC2014-21 and R2014-6 on December 22, 2014, is approved.
