WHEREAS, the United States Postal Service (“the Postal Service”) and [REDACTED] (“Customer”) entered into a shipping services contract regarding Parcel Select service on October 12, 2012.

WHEREAS, the Parties desire to amend Paragraph I.E.5, replace Table 1, add Paragraph I.K., and amend the contract expiration date in Section III under this contract.

NOW, THEREFORE, the Parties agree that the contract is hereby amended as detailed below. The existing contract remains unchanged in all other respects. This amendment shall become effective one business day following the day on which the Commission issues all necessary regulatory approval.




