**NOTICE OF UNITED STATES POSTAL SERVICE OF FILING MODIFICATION TO  
GLOBAL EXPEDITED PACKAGE SERVICES – NON-PUBLISHED RATES 4  
VERSION 2 CUSTOMER CONTRACT SERIAL NUMBER ENDING: 0108**  
(June 17, 2015)

On December 9, 2014, the United States Postal Service (Postal Service) gave notice of filing, in the above-referenced docket, Global Expedited Package Services – Non-Published Rates 4 (GEPS NPR 4) Version 2 customer agreements with serial numbers ending in 0103 to 0105 and 0108 to 0111.<sup>1</sup> This notice concerns the customer agreement with the serial number NPR4.2-FY15-OCT14-N-T5-0108, an unredacted version of which was filed with the Commission under seal, as part of the Postal Service's December 9, 2014 notice of filing seven contracts in this docket.

A modification of the customer agreement with the serial number NPR4.2-FY15-OCT14-N-T5-0108 was recently signed. The modification revises Article 2 so that the Mailer may pay postage to the USPS through two USPS-approved PC Postage Providers. The modification will go into effect on June 22, 2015.

A redacted version of the modification is filed publicly as Attachment 1. With respect to the non-public version of the modification that is filed under seal, the Postal

**MODIFICATION ONE TO THE  
GLOBAL CUSTOMIZED MAIL AGREEMENT BETWEEN  
THE UNITED STATES POSTAL SERVICE AND**

This Modification amends the Global Customized Mail Agreement ("Agreement") between [REDACTED] ("Mailer"), with offices at [REDACTED] and the United States Postal Service ("USPS"), an independent establishment of the Executive Branch of the United States Government, with offices at 475 L'Enfant Plaza SW, Washington, DC 20260-9998, signed by the Mailer on November 7, 2014, and signed by the USPS on November 12, 2014. The Mailer and the USPS may be referred to individually as a "Party" and together as the "Parties."

The purpose of this Modification is to revise Article 2 to state:

**ARTICLE 2. CHOICE OF PAYMENT METHOD**

By initialing one of the following two options, the Mailer hereby selects a postage payment method. This Agreement is not valid unless either Option A or B is selected.

[REDACTED] Option A Postage Payment through a PC Postage Provider

The Mailer shall pay postage to the USPS through the intermediary of a USPS-approved PC Postage Provider(s) that the USPS has authorized to offer services to contract rate customers.

The Mailer hereby chooses [REDACTED] as its USPS-approved PC Postage Providers.

[REDACTED] Option B Postage Payment through a Permit Imprint using USPS-  
provided Global Shipping Software

The Mailer shall pay postage to the USPS through the use of a permit imprint subject to the conditions stated in IMM 152.6 and DMM 604.5.

All other terms and conditions of the Agreement shall remain in force.

The Mailer acknowledges that the Modification and supporting documentation will be filed with the Postal Regulatory Commission ("Commission") in a docketed proceeding (CP2014-22 Serial Number NPR4.2-FY15-OCT14-N-T5-0108). The Mailer authorizes the USPS to determine the scope of information that must be made publicly available in any Commission docketed proceeding in which information related to this Modification must be filed. The Mailer further understands that any unredacted portion of the Modification or supporting information will be available on the Commission's public website, <http://www.prc.gov>. In addition, the USPS may be required to file information in connection with this instrument (including revenue, cost or volume data) in other Commission dockets, including Commission docket numbers ACR2015 and ACR2016. The Mailer has the right, in accordance with the Commission's rules, to address its confidentiality concerns directly with the Commission. The procedure for making an application to the Commission for non-public treatment of materials believed to be protected from disclosure is found at Title 39, Code of Federal Regulations, Section 3007.22 found on the Commission's website, <http://www.prc.gov/Docs/63/63467/Order225.pdf>.

The Parties may execute this Modification in one or more counterparts (including by facsimile or by electronic means such as .pdf format). Not all Parties need be signatories to the same document. All counterpart signed documents shall be deemed an original and one instrument.
