**REQUEST OF THE UNITED STATES POSTAL SERVICE TO ADD
PRIORITY MAIL EXPRESS & PRIORITY MAIL CONTRACT 19 TO
COMPETITIVE PRODUCT LIST AND NOTICE OF FILING (UNDER SEAL) OF
UNREDACTED GOVERNORS' DECISION, CONTRACT, AND SUPPORTING DATA
(July 24, 2015)**

In accordance with 39 U.S.C. § 3642 and 39 C.F.R. § 3020.30 et seq., the United States Postal Service hereby requests that Priority Mail Express & Priority Mail Contract 19 be added to the competitive product list within the Mail Classification Schedule.¹ This is a competitive product not of general applicability within the meaning of 39 U.S.C. § 3632(b)(3).² Attachment A is a redacted version of the Governors' Decision and accompanying analysis.³ An explanation and justification is provided in the Governors' Decision and analysis, which are being filed in unredacted version under seal.⁴ Attachment B is a redacted version of the contract. Attachment C shows the requested changes in the Mail Classification product list with the addition underlined.⁵ Attachment
