**NOTICE OF THE UNITED STATES POSTAL SERVICE OF FILING  
REVENUE COLLECTION REPORT FOR QUARTER 3 OF FISCAL YEAR 2015**  
(August 19, 2015)

In accordance with Order No. 2075, issued on May 2, 2014,<sup>1</sup> the Postal Service hereby submits its report on the amount of exigent surcharge revenue collected for the quarter ending June 30, 2015 (“Revenue Collection Report” or “Report”).<sup>2</sup> As set forth in the Report filed with this pleading, the Postal Service collected \$505.0 million in exigent surcharge revenue in Q3 of FY2015. Since the exigent surcharge was implemented, the Postal Service has collected \$3.016 billion in cumulative surcharge revenue.

<sup>2</sup> The Revenue Collection Report is being filed with this pleading as *ExigSrchgRevREPORT(3Q15).xls*. Due to the price change that went into effect in the middle of the period of this Report, unlike in previous quarters, the Postal Service is filing three supporting workpapers for Standard Mail, Package Services and Special Services: one excel workbook presenting the revenue generated before the price change, denoted by “pre” in the file name; one workbook presenting the revenue generated after the price change, denoted by “post” in the file name; and one summary workbook. For the remaining classes, separate “BR” (Before Rates), “AR” (After Rates) and summary tabs in their respective workbook present the complete volume and revenue totals for the quarter. In addition, an excel workbook showing the cumulative surcharge revenue for Q2, Q3, and Q4 of FY2014, and Q1, Q2, and Q3 of FY 2015 is being filed as *ExigSrchgRevCUMLTV(2Q14-3Q15).xls*.
