**CUSTOMER CONTRACT FILING NOTICE FOR  
GLOBAL EXPEDITED PACKAGE SERVICES – NON-PUBLISHED RATES 7  
SERIAL NUMBERS ENDING: 0002, 0006, AND 0008 TO 0010  
(September 10, 2015)**

In compliance with Order No. 2558,<sup>1</sup> the United States Postal Service gives notice of filing Global Expedited Package Services – Non-Published Rates 7 (GEPS NPR 7) customer agreements with serial numbers ending in 0002, 0006, and 0008 to 0010.<sup>2</sup> The effective dates for the five agreements filed with this notice are listed below.

The Postal Service is filing these contracts with the Commission under seal. The agreements are derived from a common template<sup>3</sup> and would appear essentially the same when redacted. Therefore, the Postal Service requests that the Commission consider the redacted version of the customer agreement with serial number NPR7-FY15-MAY15-N-T4-0001, filed in this docket as Attachment 1 to the Postal Service's notice dated July 24, 2015,<sup>4</sup> as representative of the contracts filed.

The unredacted versions of the inputs worksheets that were used to generate customer-specific rate tables for the agreements for which the Postal Service is providing notice are being filed with the Commission under seal. The inputs worksheets are very similar to the inputs worksheet that was included in the Postal Service's notice dated July 24, 2015.<sup>5</sup>

The Postal Service incorporates by reference the application for non-public treatment that was filed in conjunction with the Postal Service's June 19, 2015, notice in this docket.<sup>6</sup> The application protects from disclosure the information that has been redacted from the contract and the inputs worksheet that the Postal Service is filing publicly today with this notice.
