**CUSTOMER CONTRACT FILING NOTICE FOR  
GLOBAL EXPEDITED PACKAGE SERVICES – NON-PUBLISHED RATES 8  
SERIAL NUMBERS ENDING: 0117, 0119  
(February 25, 2016)**

In compliance with Order No. 2774,<sup>1</sup> the United States Postal Service gives notice of filing Global Expedited Package Services – Non-Published Rates 8 (GEPS – NPR 8) customer agreements with serial numbers ending in 0117 and 0119.<sup>2</sup> The effective dates for the two agreements filed with this notice are listed below.

The Postal Service is filing these contracts with the Commission under seal. The agreements are derived from a common template<sup>3</sup> and would appear essentially the same when redacted. Therefore, the Postal Service requests that the Commission consider the redacted version of the customer agreement with serial number NPR8-FY16-NOV15-N-T0-0003, filed in this docket as Attachment 1 to the Postal Service's notice dated December 10, 2015,<sup>4</sup> as representative of the contracts being filed.

The unredacted versions of the inputs worksheets that were used to generate customer-specific rate tables for the agreements for which the Postal Service is providing notice are being filed with the Commission under seal. The inputs worksheets are very similar to the inputs worksheets that were included in the Postal Service's notices concerning the first group of GEPS – NPR 8 contracts filed in this docket.<sup>5</sup>

The Postal Service incorporates by reference the application for non-public treatment that was filed in conjunction with the Postal Service's October 9, 2015, notice in this docket.<sup>6</sup> The application protects from disclosure the information in the contracts and the inputs worksheets that the Postal Service is filing today with this notice.
