PUBLIC REPRESENTATIVE COMMENTS ON
POSTAL SERVICE NOTICE OF AMENDMENT
TO PRIORITY MAIL CONTRACT 105

(March 4, 2016)

The Public Representative hereby provides comments pursuant to Order No. 3105.¹ In that Order, the Commission established the above referenced docket to receive comments from interested persons, including the undersigned Public Representative, on a Postal Service Notice of a change in the terms of Priority Mail Contract 105.² Attachment A to the Notice consists of a redacted version of the Amendment to Priority Mail Contract 105.

In Order No. 2317, the Commission approved the Postal Service's request to add a new product identified as Priority Mail Contract 105 to the Competitive product list.³ The Amendment replaces Section I.D. and removes Section I.E. Contract 105, as amended, is currently scheduled to expire in approximately 3 years from the date of the Order Adding Priority Mail Contract 105 to the Competitive Product List.

The Postal Service asserts that the Amendment will not materially affect the cost coverage of Contract 105. Notice at 1. The Postal Service adds that as a result, the supporting financial documentation and financial certification initially provided in Docket

Nos. MC2015-20/CP2015-25 remains applicable. *Id.* The Postal Service also states that the Amendment will take effect one business day following the day on which Commission completes its regulatory review of this filing. *Id.*

COMMENTS

The Public Representative has reviewed Priority Mail Contract 105 and the Postal Service's Amendment thereto. Based upon that review, the Public Representative recommends Commission approval of the Amendment to Contract 105.

The Postal Service's assessment that the Amendment will not materially affect the cost coverage of Contract 105 is reasonable. As filed, the Amendment makes minor adjustments to the terms of the contract. The Public Representative therefore believes that these changes are not likely to have a material effect on cost coverage of Contract 105.

In addition, the Postal Service must file revenue and cost data for Contract 105 in future Annual Compliance Reports. This data will permit the Commission to annually review the financial results for Contract 105 in future Annual Compliance Determination (ACD) reports for compliance with 39 U.S.C. § 3633(a).

The Public Representative respectfully submits the foregoing comments for the Commission's consideration.
