PUBLIC REPRESENTATIVE COMMENTS ON
POSTAL SERVICE NOTICE CONCERNING MODIFICATION TWO TO A
GLOBAL EXPEDITED PACKAGE SERVICES 3
NEGOTIATED SERVICE AGREEMENT

(March 24, 2016)

I. Introduction

The Public Representative hereby provides comments pursuant to Order No. 3158.¹ In that Order, the Commission established the above referenced docket to receive comments from interested persons, including the undersigned Public Representative, on a Postal Service Notice of filing Modification Two to a Global Expedited Package Services 3 (GEPS 3) Negotiated Service Agreement (Modification Two).²

The Commission approved the original GEPS 3 contract in Order No. 2528, dated June 3, 2015.³ The first Modification to the original contract was approved by the Commission in Order No. 3024 (Modification One).⁴ The modification revised a few articles in the Agreement and replaced Annex 1. On March 16, 2016 the Postal Service filed a Notice that it had agreed to a second modification to the existing GEPS 3 negotiated service agreement subject of the current docket (Modification Two).

Modification Two amends Annex 1 of the agreement. Notice at 1. To support the Notice, the Postal Service filed a certified statement of compliance with 39 U.S.C. § 3633(a), a redacted copy of the Modification Two and redacted versions of the revised supporting financial data.

II. COMMENTS

The Public Representative has reviewed the Postal Service's Notice, the documentation included with the original Agreement, as well as Modification One and Modification Two and all supporting financial data filed under seal as part of the Notice. The negotiated prices in the Agreement as amended should continue to generate sufficient revenues to cover costs. Based upon that review, the Public Representative concludes that the instant Modification should be approved by the Commission.

The Public Representative respectfully submits the foregoing comments for the Commission's consideration.
