WHEREAS, the United States Postal Service (“the Postal Service”) and  (“Customer”) entered into a shipping services contract regarding Priority Mail service on March 8, 2014.


WHEREAS, the Parties desire to amend Section I.E, under this contract.

NOW, THEREFORE, the Parties agree that the contract is hereby amended as detailed below. The existing contract remains unchanged in all other respects. This amendment shall become effective two business days following the day on which the Commission issues all necessary regulatory approval.

Replace Section I.E, as follows:

I. Terms

- E. On the effective date of this amendment, the Customer shall receive Tier 2 rates until June 30, 2016. After June 30, 2016 Customer shall receive the applicable rate in Table 2 below, based on Customer’s volume in the previous Contract Quarter.
