ORDER APPROVING MODIFICATION THREE
TO GLOBAL RESELLER EXPEDITED PACKAGE SERVICES 1
NEGOTIATED SERVICE AGREEMENT

(Issued May 12, 2016)

On May 11, 2016, the Postal Service filed notice of Modification Three to the negotiated service agreement approved in this proceeding (Existing Agreement).¹ Modification Three provides that the Existing Agreement will expire on June 30, 2016.² The expiration date identified in Modification Three replaces the Existing Agreement's

May 31, 2016 expiration date.³ Modification Three does not make any other changes to the Existing Agreement. See Notice, Attachment 1.

In support of the revised expiration date, the Postal Service states that it intends to file a successor to the Existing Agreement in a new rate docket, and seeks Commission approval of Modification Three to maintain continuity of pricing and other terms and conditions of the Existing Agreement. *Id.* at 1-2.

The Commission approves Modification Three. The brief extension will not impair the ability of the Existing Agreement to comply with 39 U.S.C. § 3633, will avoid disruption in contract administration, and will not prejudice any person. Consequently, the Existing Agreement is modified to continue through June 30, 2016, unless terminated earlier pursuant to the terms of the agreement.

It is ordered:

1. The Commission approves Modification Three, filed by the Postal Service on May 11, 2016.
2. The Mail Classification Schedule will continue to list the Existing Agreement according to the terms set forth in Modification Three.
