ORDER APPROVING MODIFICATION ONE TO AN INBOUND
COMPETITIVE MULTI-SERVICE AGREEMENTS WITH FOREIGN POSTAL
OPERATORS 1 NEGOTIATED SERVICE AGREEMENT

(Issued June 16, 2016)

The Postal Service seeks to modify an Inbound Competitive Multi-Service Agreements with Foreign Postal Operators 1 negotiated service agreement.¹ For the reasons discussed below, the Commission approves Modification One.

In Order No. 2578, the Commission approved the Inbound Competitive Multi-Service Agreements with Foreign Postal Operators 1 negotiated service agreement (Existing Agreement).² The Notice states that the Postal Service and Hongkong Post have signed Modification One to extend the expiration date of the Existing Agreement until September 30, 2016. Notice at 1. No other changes to the Existing Agreement are proposed. See Notice, Modification One. The Postal Service states that the 3 month extension corresponds with the accounting practice of invoicing under the Existing Agreement on a quarterly basis. See Notice at 1.

Modification One does not affect the cost coverage or compliance with existing regulatory requirements for the Existing Agreement, and in the absence of harm to the public interest or prejudice to any party, the Commission approves Modification One. The Existing Agreement is modified to continue through and will expire on September 30, 2016, unless terminated earlier pursuant to the terms of the agreement.

It is ordered:

1. The Commission approves the Inbound Competitive Multi-Service Agreements with Foreign Postal Operators 1 negotiated service agreement, as modified.
2. The Postal Service shall notify the Commission if the Existing Agreement, as modified, terminates prior to the scheduled expiration date.
