**AMENDMENT TWO OF  
SHIPPING SERVICES CONTRACT

WHEREAS, the United States Postal Service ("the Postal Service") and [REDACTED] ("Customer") entered into a shipping services contract regarding Priority Mail inbound service on May 12, 2015.

WHEREAS, the Parties desire to amend Section I.G under this contract.

NOW, THEREFORE, the Parties agree that the contract is hereby amended as detailed below. The existing contract remains unchanged in all other respects. This amendment shall become effective one business day following the day on which the Commission issues all necessary regulatory approval.

[Replace Section I.G in its entirety, as follows:]

**I. Terms**

- G. From the effective date of the contract until December 31, 2016, Customer will receive the Tier 2 rates for inbound returned Priority Mail Contract Packages. Customer shall expect to receive a minimum of [REDACTED] Contract Packages during each Contract Quarter for the term of this contract. If the volume falls below [REDACTED] of the quarterly average per Contract Quarter, the Postal Service at its sole discretion has the right to revert Customer to the most current Commercial Plus Prices.
