**REDACTED AMENDMENT TO PRIORITY MAIL CONTRACT 131**

This amendment amends the Shipping Services Contract, signed July 6, 2015, regarding Priority Mail Service, made by and between [REDACTED] (“Customer”) and the United States Postal Service (“the Postal Service” and such contract, the “Contract”).

WHEREAS, the Parties desire to amend the terms in Section I.G of the Contract.

NOW, THEREFORE, the Parties agree that the contract is hereby amended as detailed below. The existing contract remains unchanged in all other respects. This amendment shall become effective two (2) business days following the day on which the Commission issues all necessary regulatory approval.

[Replace Section I.G in its entirety, as follows:]

**G. Annual Adjustment**

1. For subsequent years of the contract, beginning on the first anniversary of the contract’s effective date, customized prices under this contract will be the lesser of: (a) the previous year’s prices plus the most recent (as of the anniversary date) percentage change in prices of general applicability for Priority Mail Commercial Base, as calculated by the Postal Service, or (b) the previous year’s prices plus [REDACTED]
2. Customized prices for the subsequent years will be calculated by the Postal Service and rounded up to the nearest whole cent. If the Postal Service maintains or decreases published rates of applicability for Priority Mail Commercial Base, there shall be no change to contract pricing for that Contract Year.
