This amendment amends the Shipping Services Contract signed July 30, 2015, regarding Priority Mail Express Service, made by and between [REDACTED] (“Customer”) and the United States Postal Service (“the Postal Service” and such contract, the “Contract”).

WHEREAS, the Parties desire to amend Sections I.G., and I.H.

NOW, THEREFORE, the Parties agree that the contract is hereby amended as detailed below. The existing contract remains unchanged in all other respects. This amendment shall become effective two (2) business days following the day on which the Commission issues all necessary regulatory approval.

[Section I.G shall be replaced in its entirety, as follows:]

I. Terms

G. Volume Commitment. Customer shall mail at least [REDACTED] Contract Packages annually.

[Section I.H shall be replaced in its entirety, as follows:]

I. Terms

H. Priority Mail Express Prices. From the effective date of this amendment, until the anniversary of the contract’s effective date in 2017, Customer shall pay the Tier 1 prices as outlined in the table below. For every contract year thereafter, Customer shall pay the appropriate tier prices based on the volume of Contract Packages shipped in the previous contract year, pursuant to the tables below.
