Negotiated Service Agreement (NSA) Statistics

Fiscal Year 2023, Quarter 3 Update

1. Breakdown of NSAs:

The Postal Service maintains contracts with private businesses and other entities to ship items via the USPS' portfolio of package products. In quarter three of fiscal year 2023, the USPS maintained 16 different variations of Domestic Negotiated Service Agreements (NSAs), and several variations of International NSAs for both inbound and outbound pieces, leading to 843 contracts that were in effect in the quarter. Out of the 843, 48 are newly established contracts that went into effect in the third quarter of fiscal year 2023.



2. Early Termination vs Extension:

Negotiated Service Agreements can be terminated before their original date of expiration, as well as be extended past their original date of expiration for a multitude of reasons. Of the 843 NSAs that were in effect in quarter three of fiscal year 2023, 43 NSAs were terminated early, while 41 NSAs were extended in the quarter.



3. When Did the NSAs Begin?





4. NSAs Approved Over the Years:

As of July 1, 2023, the Commission has approved 178 NSAs in FY2023, 151 of which are domestic, and 27 are international. The following graphic also shows the number of NSAs approved by the Commission during the past fifteen fiscal years. These NSAs require prior Commission approval for compliance with statutory and regulatory criteria.



5. NPRs Implemented Over the Years:

Non-published rates (NPR) products authorize the Postal Service to enter into contracts featuring negotiated rates without prior Commission approval. Such contracts must comply with Commission classification and regulatory requirements, including preapproved pricing formulas, minimum cost coverage, and documentation. The absence of pre-implementation review streamlines the approval process, providing the Postal Service with additional flexibility. As of July 1, 2023, the Postal Service has implemented 245 (187 PMNPR-2 and 58 GEPS NPR 15) contracts in FY 2023 under NPR products. The following graphic shows these contracts, as well as those implemented during each of the past twelve fiscal years. All NPR products are Competitive.
